## HelioFidem and OTM Eko Energi announce Joint Development Agreement (JDA) to develop 100 MW of Solar Projects in Sweden

**Holsbybrunn – Sweden, 22 May 2024:** HelioFidem, an international renewable energy developer headquartered in the UK and USA, and OTM Eko Energi, a Vetlandabased specialist of solar and battery-storage solutions in Sweden, are pleased to announce the signing of a Joint Development Agreement (JDA) to realize a pipeline of solar projects across Southern Sweden.

Together, the companies are developing a portfolio of utility-scale ground mounted PV solar projects (both stand-alone PV, and hybrid with battery storage) in Sweden's "SE3" and "SE4" electricity bidding zones – areas that are particularly well-poised to benefit from the introduction of localized solar energy generation.

Sweden's southern regions have the highest demand for electricity in the country, while at the same time facing the country's highest electricity prices driven by deficits in power generation. Here, solar energy represents a unique opportunity – taking advantage of the area's favorable irradiation resource as a natural complement to strengthen the local energy mix.
